Findings:

Political Party (PP) has received coupons for tea from '046 ', No. 176 321, dated 17.07.2012 -165.10 EUR No. 176 344-in the amount of 120.00 euros.

Payments of physical persons based on the decision of PP or contract -tax at source should be retained and paid by the PP.

Recommendations:

Political entity should accept tax invoices because it is in the position of the legal person, coupons and fiscal coupons are issued only to physical persons.

We recommend PP to pay the TTS and pension contribution to physical persons.
