Findings:

Forms-reports submitted after the deadline.

There is no specification of those who were given sport equipments, firewood.

Invoices on behalf of physical persons Velimir Savic and Rada Trajkovic.

Import of goods (25 cell phones) without payment of value added tax on imported goods.

Supplies- fiscal coupons purchases.

During the year it is not committed any payment of taxes and contributions in the personal income or rent tax.

Recommendations:

Political party must respect the deadline for submission of annual financial reports according to Article 15 of the Law Nr.03/L-174 Law for financing political parties.

Must adhere the format defined forms of CEC.

Must adhere to Article 15 paragraph 3 of the Law Nr.03/L-174 Law for financing political parties, for the content of documents in an annual financial report.

In order to respect the principle of transparency political party should liquidate the bank account not to carry cash payments.

Political parties should use tax invoices because it has the status of legal person whereas coupons and fiscal coupons can be used only for physical persons.

Must apply the applicable tax laws of the Republic of Kosovo, especially for TTS and pension contributions in personal income and tax on rent.

Political party must increase the level of professionalism of financial representative or the person responsible for keeping records and compilation of financial reports through trainings or continuing professional education.
