The invoices of expenses presented in forms are not submitted in the report.

There is no evidence for collection for the incomes or payments of expenses paid from checkout or bank account.

Salaries are presented but there is no evidence of payment of tax and pension contributions.

## **Recommendations:**

Political party most refrain forms format defined by CEC.

Must adhere to Article 15 paragraph 3 of the Law Nr.03/L-174 Law for financing political parties, for the content of documents in an annual financial report.
