In position F.8 of income statement – Total expenses is incorrectly filled with the amount of 3.600.00 it must be 5,900.00

According to the form for Donations and Contributions in cash the person:

During the year has contributed with amount higher than that allowed by the Law Nr.03/
L-174 on financing political parties, Article 5 paragraph 1 item 1.1.

Salary costs 3,600.00 Euro, rental costs 4,800.00 Euro, telephone expenses, electricity, and water costs of 1,100.00 Euro were not supported by documentation.

#### **Recommendations:**

In the case of receiving donations from physical persons political party must respect the Law No.03/L-174 on financing political parties, Article 5, paragraph 1, point 1.1 and Article 17 of Regulation 01/2008 on the registration and operation of political parties.

Must adhere to Article 15 paragraph 3 of the Law Nr.03/L-174 Law for financing political parties, for the content of documents in an annual financial report.
