Some notes are missing for contributors: address, date when payment was done, personal number of Faton Abdullahu.

Incomes are not presented in the form of disclosure accounts.

Expenses of rental costs, electricity, and water are shown only for 11 months- but no supporting documents are presented.

Recommendations:

Financial resources of a political party should be categorized according to Article 4 of the Law Nr.03/L-174- Law for financing of political party - incomes from the Fund for support of the political parties through the Budget of the Republic of Kosovo are not donations.

In the case of receiving donations from physical persons political party must respect the Law No.03/L-174 on financing political parties, Article 5, paragraph 1, point 1.1 and Article 17 of Regulation 01/2008 on the registration and operation of political parties.

Must adhere to Article 15 paragraph 3 of the Law Nr.03/L-174 Law for financing political parties, for the content of documents in an annual financial report.
