Recommendations:

Must adhere to Article 15 paragraph 3 of the Law Nr.03/L-174 Law for financing political parties, for the content of documents in an annual financial report.

Political party shall arrange the billing expenses in behalf of the political entity, on the contrary documentation can be considered as invalid and not accepted.
