Incomes of 60 Euros from membership are not included in the incomes of balance sheet and profit and loss statement but are not shown in the form of contributions and donations in cash.

From all invoices only the electricity invoice of 280.00 Euro was presented in the name of LPK Political Party- therefore not PSK and the order for the payment of salaries Atdhe Ahmetajt.

No payments of pension contributions or tax on salaries for wages of Atdhe Ahmetajt and compensation for Haki Morninen and Nuhi Paçarizin.

Recommendations:

Must adhere to Article 15 paragraph 3 of the Law Nr.03/L-174 Law for financing political parties, for the content of documents in an annual financial report.

Must present all incomes of the reporting periods (Article 6, paragraph 2 of Law No.03/L-174- Law on financing political parties.

Incomes in the statement and in disclosure must be harmonized.

Non-payment of taxes and contributions on time may cause implications under the tax law.
